- To then specifically expand the Scope of Issues being promoted by the millions of brave protestors and help grow their numbers by many more millions in July and August to Demand immediate action on these same issues. And others I will be bringing forward.
- To patriotically promote the elected end of the failure Trump and the Republican Party in Congress, including all 23 US Senate and 205 US House seats up for election on November 3rd. As well as, Republicans at the State and Local levels across the nation. Because they sure as hell no longer work for our Common Good...
- And finally for the American Electorate – the Voters – to more than encourage all Democrats and Independents to embrace these very proposals and more of the 40+ proposals in the problem-solving Platform.

Now let us bring fair and true Justice down upon George Floyd's killer! And declare our Justice to be delivered in all such heinous cases.

The Best Solutions are Simple and Actually Address the Problem at Hand

Simply stated, this Reform declares and Demands that if a man or woman of their own free will acts to take the physical life of one (1) or more men, women or children – and that crime is provable based on hard evidence such as video, multiple credible witnesses, etc., that the Obvious Guilt Law (OGL) Death Penalty Sentence must be applied. These are the OGL Reform Guidelines:

- The perpetrator will receive a single and “near-term” standard Court Trial.
- The perpetrator will be rightfully convicted of murder based upon hard and absolute evidence.
- No Plea Bargaining will be permitted.
- No Insanity Plea will be permitted. With the “possible exception” of the classic “Crime of Passion”.
- No Appeal(s) will be granted. Because of the available hard evidence in such cases.
- The criminal will then receive the only sentence allowed under the absolute OGL Sentencing Reform.
- The predetermined sentence to be ordered by the Court will be Death by Lethal Injection (DLI).
- The sentence will be properly administered no more than ninety (90) days after the date the Guilty Verdict and Sentence are handed-down by the Court.
- Thus, under the OGL Sentencing Reform, the American public’s acceptable and assigned JUSTICE will be carried out.
- Thus, the family and friends of the victim(s) will have the blessings of near-term closure of the court case and be allowed to continue their healing process in peace.
- Also, they will not be dragged into Court rooms for years, if not decades, and forced to keep re-living the horrific experience and personal loss over-and-over again. You know Victim’s Rights... What a concept!
- This OGL Reform will become a Federal Law. It will serve to over-ride any State Law(s) in such cases, including Appeals, Plea Bargains, Sentencing, and the application of the Death Penalty by Lethal Injection. And without exception.
- Therefore, setting a clear standard of Justice, that the American public both supports and Demands in all such cases.

I am challenging all Americans to join together in Demanding that the OGL Sentencing Reform be immediately implemented and Demand that it first be applied in the George P. Floyd murder case.

True Justice is really as straight-forward and uncomplicated as that folks. We are through with the never-ending “Legal Proceedings and Endless Appeals” granted to “Obviously Guilty Criminals”. We frankly have better things to spend taxpayer money on. The usual practice of the LAW in such cases, has not made Americans safer from such heinous crimes.

Time to Reassign Bad Cops NOW

This fair proposal is directed to Lieutenant Robert J. Kroll, Minnesota Police Union President, in particular!

The second action to be taken help to satisfy this proper public up-rising, is summed up by the new sign for protestors that declares, **“Reassign Bad Cops NOW”**

I propose that each police “station or barracks” be charged to identify up to two percent (2%) of the “street duty” officers (the number will vary by the size of a given barracks) that are well documented as being the worst public abusers. **And to have those Bad Cops reassigned from “street duty” no later than August 31, 2020.**

I respectfully challenge the Minnesota Police Union to immediately embrace and back this fair action. Thus, the public will see direct and corrective action being taken now! Police Unions need to back this Reform for the sake of the vast majority of their Good Cops and their overall public credibility!

As a result, both the vast majority good officers and the public will be rid of the Bad Cops. The **“Reassign Bad Cops NOW”** Reform must be accomplished nationwide this Summer and by August 31 would be appropriate!!

No More Residential Evictions thru 6-30-2021.

Once and forever, All Americans will be guaranteed a Fixed Address – a tedious, but workable program that will begin in the Covid19 Era. That is, starting now!

Starting in mid-March, when Covid19 first hit our economy, tens of millions of hard working people were suddenly unemployed and thru no fault of their own. Add to that, the hard fact is that half of all Americans are living month-to-month and have or had only some \$400 in saving – before Covid19 threw tens of millions out-of-work.

The week ending July 11, was the 17th straight week that more than one (1) million States Unemployment Claims were filed.

Thus, paying the mortgage, rent or lot fees quickly became a severe problem for many. To address that situation, most if not all State Governors declared that no one could be evicted for such non-payment of Rent thru June 30, 2020. That was a practical first step.

Our Approach is as Follows

The Governors in all 50 States and the DC government controls this decision, not Congress or the White House.

There will be No Residential evictions due to non-payment of Mortgage, Rent or Lot Fees allowed nationwide through **June 30, 2021**. Yes, some twelve (12) months from now. That is a quite realistic approach given the lingering Covid19 driven unemployment situation. You ask, how that can happen without bankrupting the nation?

Simply put, We the People, bailed the Banks and Wall Street out in 2008/2009.

Therefore, they will now return the favor and bail us out in 2020/2021. Yes, they may make less in profits for a year or two (2) but such is life. They will just be told to deal with it!

And without a single taxpayer dollar of our help. That is not negotiable! This is where the Banks and Wall Street will work their spreadsheet magic!!

Plan Guidelines

1. Typically, when Mortgage payments on a residential (owner occupied) property are missed the Leaders have the option (called forbearance) of placing the missed payment onto the end of the associated loan. It was reported in a recent Senate hearing that in June some 4.7 million Mortgage payments were missed, as well as, up to 1/3 of all Rental payments which is not a precise estimate, but frightening. And that was only June!
2. The Federal and State governments will not borrow money to pay anyone's Mortgage or Rent or Lot Fees. That truly would be national financial suicide!
3. Rental Landlords with Mortgages on any tenant occupied rental properties where rent is not being paid will also be allowed to have missed payments moved to the end of the applicable property loan and again thru **June of 2021**, as needed. Mobile Home loans are often set-up as vehicle loans. They will be included under this program.

4. The Landlords, Tenants, Homeowners, and Lenders are all put on Federal Notice not to abuse this program.
5. In all situations, monthly utility, tax, and insurance payments must still be dealt with. Responsible Home Owners and Rental Landlords will be given special financing options by Lenders to help them through the next year or two (2). This will be worked out with the Lenders and without taxpayer support.

Again, these are hard, Depression Level times and will be approached realistically to keep American families in their current Housing. Greed cannot be tolerated. **No more homelessness!**

Extra Financial Resources Will be Required for Housing and Food Proposals

To deal realistically with funding both the Housing and Food Reforms in this Depression Level event, Elizabeth Warren's Wealth Tax concept will be reviewed for probable application.

Also, numerous millionaires and billionaires are volunteering to help their fellow Americans. And good for them. They are setting the example. Their giving will be coordinated. Those people include Abigail Disney (yes that family) and the *Millionaires for Humanity* group.

And to anyone that begins to whine about "re-distribution of wealth" I do virtually slap them. I am not a Liberal/Progressive. I am a public problem-solver. I declare to all, that the historic and near criminal American wealth imbalance that Bernie Sanders made the nation so aware of, has only made worse by Covid19. The proper name for what we will do starting in 2020, is the fair and equitable "de-centralization of wealth". Prudent and practical Domestic policy.

The long existing national disgrace of Food insecurity, has exploded into a full blown public Crisis due to Covid19. Some 1 in 6 Americans and as many as 1 in 4 children have Food Insecurity. We will finally confront and resolve this inhuman condition.

Plan for Food Industry Reformation

1. To be clear, We are Demanding the complete Reformation of the Food Industry in America. From Farms and Fishing to the Grocery Store shelves. Because that is what it will require!
2. The vast majority of Americans will vote for what you are about to review in a heartbeat. Whenever I have reviewed this proposal with people in recent years, they are in favor of it because Grocery prices are out-of-control. Their first comment is normally that we must take care of the Farmers. And, of course, we will.
3. Food Prices will need to be capped by August and remain so well into 2021 as we work thru this corporate transition.
4. Also, product content sizes cannot be reduced until further notice.
5. Most Grocery Store corporations, with the exception of high-end stores like Whole Foods will need to begin their involuntary corporate conversion to Commissary type operations. Yes, this will include Walmart! All this because the People cannot afford to buy groceries. And Food is sort of a necessity isn't it.
6. All Food related products will be removed from Commodities Market trading.
7. The entire Food Industry will in the next few years become a practical Public Utility.
 - a. Existing stockholders will be bought out over a number of years.
 - b. These will remain private companies, but their charter will be to guarantee all Americans have a locally available food supply at the lowest prices possible.

This unique and unexpected term I created means, *Refund the Covid19 Unit Charges (CUC)*. This Public Action proposal directly calls out the obscene and predatory over-charging by Vendors for Medical Supplies and Services (MSS) since the very start of the Covid19 National Health Crisis.

Let's Follow the CUC to Windfall Profits

Here is a prime example taken from one (1) of Governor Andrew Cuomo's first daily Press conferences in March. His example was, "The last time we ordered this particular item the unit price was **80 cents** (\$.80). Today the unit price is **\$4.00**". Thus, the abusive CUC overcharge was **\$3.20 per item**.

That over-pricing will be publicized, stopped, and over-charges-to-date will be Refunded starting this Summer! The disgraceful enormity of these CUC overcharges will disgust the Public. In this Crisis corporations will need to be satisfied selling far more products and services at the pre-Covid19 prices. That alone is business volume and profit they did not expect in 2020, or in 2021 to come. They will start to Refund the CUC Now...

It is like charging soldiers more for bullets and bandages in wartime. The truly darkest side of the *Low Supply and High Demand* mentality showed its ugly face and crushed State and other budgets.

This corporate greed, is the direct result of the Trump not doing his job again. He would not prudently and aggressively enforce the Defense Production Act (DPA) to cap costs and control the production all needed Medical Supplies in this true National Health and Economic Crisis.

The immediate and on-going impact on State budgets, has already directly contributed to the lay-off of well over 1.5 million State and Local employees. The CUC's also hit hospitals, business entities of all types and sizes, families, and others. One hard reason why we are still hearing that hospitals do not have enough PPE, is simply because many cannot afford to buy it, even if they can find it.
