US Immigration Reformation Proposal – Demand

Without further delay let us review the US Immigration Reformation (USIR) Proposal. I will restate that TIPA Proposals have a 65% or better acceptance rate with the American public. This Immigration Reform Proposal is part of the problem-solving Platform of The Independent Party of America (TIPA).

We the People Do Hereby Demand

Therefore, We the People do hereby Demand the following Immigration Reform Proposal (IRP) provisions to be implemented – all but immediately:

1. It is obvious to state that every White House Administration and US Congress for the last 35 years has effectively played kick-the-can down-the-road in stopping the abuse of our land and airport ports-of-entry. Thus, We the People declare that the border be closed until further notice, which will probably mean permanently.

And, that the American National Identification Program (ANIP) be implemented immediately.

2. ALL Non-formal immigration into the US will be suspended as of April 15, 2022. This Reformation is designed to permanently end America's Illegal Occupant (IO) problem. There will be no more IOs!
3. The simplest Rules is the easiest to announce, follow, and enforce.

This is the simplest approach. The easiest for the public to oversee.

Therefore, the Suspension of the flow of anyone and everyone across the US/Mexico, means NO new immigrant cases will be created after 4-15-22. PERIOD! No new immigration cases will be created after 4-15-22.

From that great day on, even if someone steps foot on our land they will be picked up, transported to the nearest land Port-of-Entry, and handed over to the Mexican border authorities. They let them travel to our border and they will now get them right back! So, it will be to their advantage to stop flow themselves. Men, women, children, 9-month pregnant women, and old people. *No one* really means *no one* in 2022.

Lobbying groups can start all the useless law suits they want, but the US border will be closed on 4-15-22. Law suits will be rejected.

4. Confronting the International Airport immigration violations will be a bit more difficult, but can be done. US Immigration has had counts on “overstays” for many years, but they have not been prosecuted. The airlines for years have successfully pressured the Federal Aviation Administration (FAA) not to “complicate” passenger loading and unloading procedures. That pressure will be ignored going forward.

I understand that Australia has a very effective system, but one (1) that is not as good as Israel’s system.

5. This Immigration Suspension will also include what is generally referred to as “Chain Migration”. It is a well-violated backdoor into our nation that will finally be plugged – and permanently!
6. During the first few years of the Immigration Reformation, we will rapidly implement the American National Identification Program (ANIP). America is one (1) of the few nations not to have such a critical national administrative system. It is required for us to better manage population movement and to control Social Services budget\$.
7. The ANIP Badge will contain and track at least a person’s photo, figure print(s), address, and other data, as required.
8. The ANIP will only be used for government Population Management programs and will be secured. It will be abused like the Social Security Number (SSN) has been for commercial uses. Literally hundreds of IOs are walking around with forged paperwork with duplicate SSNs.
9. All citizens will have an ANIP Badge. All legally registered, long-term non-citizens, foreign students, foreign workers of all types, and any other Legal Occupants (LOs) will have a so designated ANIP Badge.
10. We will work aggressively until the existing backlog of all known I/Os, is processed and all court actions are closed. Some percentage of the IOs will be allowed to stay, while the rest will be deported. And that includes men, women, and children.

Those that stay will get an appropriate ANIP Badge. However, they will not automatically receive citizenship and may never to be allowed to.

There will come a time when there are no more IOs in America or dam close to it! And then, all the federal, state, and local budgets now being wasted processing the IOs will be freed up for better purposes. Such as helping our own people. *Amen!*

11. We will work aggressively to identify everyone else that is not here legally. Please note that some in this group of IOs are active criminals. They will be dealt with accordingly. The longer it takes to identify such persons, the less kind our courts will be. Such persons could get smart and exit America on their own.

12. We would prefer that anyone that enters the US in 2022, is made very aware that they may not be allowed to stay. That we can be sure will be negotiated, but a hard line is drawn! Some 36 years of IOs is way too much.

Finally, any babies born to women that were already pregnant when entering our country in 2022 will be excluded from US Citizenship consideration. The 14th Amendment be damned in such situations anymore. Legislation will be implemented to remove yet another well-abused backdoor method of entering the US! FINALLY!

Birthright citizenship is guaranteed to most people born on U.S. territory by the first part of the [Citizenship Clause](#) introduced by the [Fourteenth Amendment to the United States Constitution](#) (adopted July 9, 1868), which states:

"All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside".

20-Year Census Data Race Comparisons

If ever some human statistics told a clear story about the 20 years of immigration and border abuse, the chart on the next page nails it! A few of the numbers actually shocked me! That doesn't normally happen. So, let's get to the real numbers they would rather we not be fully aware of!!

Over those 20 years:

- White American population increased only, 1.3 million; a less than 1% increase.
- Black American population increased only, 7.9 million, a 22% increase.
- Asian American population increased, 9.4 million; a 93% increase.
- Hispanic American population increased, 23.8 million; a 64% increase.

- Total American population increased, 43.0 million; a 15% increase.

The lack of White population growth is quite disturbing. The disproportionate numbers in both Hispanic and Asian population growth somewhat explains the impact of the flow of immigrants from south of the US/Mexico border and from the Asian nations via airports.

It seems fair to speculate that the majority of estimated ten (10) million IOs walking free in our borders are mostly from the nations south of the US/Mexico border.

Again, both Republicans and Democrats are equally at fault in failing to secure our national borders. Why? Because, their primary donor-base wants cheaper labor and/or more bodies legal or not to fill-up their rental units. That is far more the reality, than you may have considered, folks.

Thus, every Spring and Summer for decades, Mexico promotes the northward flow, and members of Congress throw their hands up in the air. The Party out-of-power blames the Party in-power for not doing something about it. And they both blame whomever is in the White House. The annual result is nothing gets done, except that thousands more IOs slip across our Southern border. Congress, as usual gets nothing done and the Status Quo is protected for their campaign donors.

I feel that this could be the first document that many people will review as this campaign gears up starting in mid-March. Further, that the best way to introduce this Electoral assault on the US Congress this election is in a process narrative.

We will now touch on the key 2022 campaign points, as well as, candidate qualifications and filing deadlines.

So, let's review how We the People could have real election success in 2022 removing scores and even hundreds of dysfunctional Republicans and Democrats from their seats in the US Congress and 50 Statehouses this November! The door is still wide open in most states and for seats in the US Congress, State legislatures, and offices such as Secretary of State and the Governor in some States! Yes, it is still technically possible and they do not want us to know it. Now we will!!

Consider this to be my first “project status report” about the American Reformation and Third-Party Movement – and you are my client. You and those 328,000,000 others of our citizens. Because ensuring our citizens Common Good, is why I have been working to develop all of this. So now let us join and work together to make this historic American Reformation happen.

Our Independent Platform and Campaign Strategy Are Ready

1. To begin with, polls show that a solid percentage of voters are identifying as Independents – as the Republicans and Democrats continue their legislative dysfunction. We voters would prefer to have better candidate options for various elected offices. And a real platform of solutions.

The numbers below are from Gallop polling on Party Affiliation. Those numbers are not a fluke. Independents have been higher some years.

2. In mid-March of 2022, the 2-Parties are not expecting a viable Independent Third-Party Movement to deal with. Especially the Republicans.
3. Also, the Parties are not expecting an Independent Problem-Solving Platform website CommonSense2nd.com. The TIPA Platform with 40+ solution proposals touching on social, economic, and environmental solutions. It includes several proposed Amendments to the US Constitution, either.

The 2-Parties are not prepared to debate the real solutions that our Candidates will be bringing to the Voters to earn their interest and votes. We could really challenge lazy Incumbents that are expecting another easy re-election.

4. The 2-Parties are certainly not expecting some candidate and/or a new Party Movement to Demand immediate legislative actions in the name of the American Electorate. You know, like Suspending Immigration in 2022!

To make an in-your-face, very public challenge for them to pass certain legislation and to do it long before the November 2022 Election Day! Individual members of Congress are protected from much of the public confrontations on the issues and in ways you would not expect.

Two (2) things come to my mind with this single item. **First**, most people do not know much about the various non-profit, 501(c)(3) organizations promoting everything from economic Reform to environmental causes. Those organizations collect tax-deductible donations. We send money to them so they will go fight the legislators in DC and/or 50 State legislatures for us. In reality, the US Congress is strictly protected from such aggressive non-profit group actions. Which means that if a given non-profit gets too aggressive or abusive toward a member of Congress, the member can simply call the IRS and have their 501(c)(3) non-profit status revoked!! No kidding. Get the idea, folks? Don't harass any of the Princes and Princesses. The TIPA Platform Candidates (TPC) will be getting into it with the Incumbents over real problem solutions.

The **second** item relates to the fact that Congress does have the legislative ability to do something, *anything right away*. As in a matter of days. Many people could recall a sad family situation that occurred under the Bush II Administration and was blatant social Politics. Some ten (10) years earlier a Pennsylvania woman was severely injured in an automobile accident. Medical reports indicated she was unfortunately brain dead shortly after the accident. Her husband and parents faithfully watched over her on life-support for those years.

Then, the husband determined it was finally time to let her go, which was his right to decide. The parents took exception to that action and it was all headed for court, of course. Various Rights groups jumped all over this “life” issue, of course! A Pennsylvania, US Congressman named Rick something, got loudly involved on the side of the parents and worked with President Bush. In a matter of a few days, Bush called the Congress into DC and passed legislation blocking the husband’s decision.

Thus, the Republican administration had succeeded in intentionally putting themselves in a hospital room in the middle of a family’s personal business. Rick lost favor with the many Pennsylvania voters and he was not re-elected. Good for them.

The point being, that when the White House and/or Congress desires to get something done – they can take any legislative action – very rapidly!

Instigating an Independent Movement

5. As I noted earlier, typically national Reformations or Second American Revolutions for that matter, it often requires *a spark, unique event, or a major decision point* that moves the frustrated Masses to Demand and take corrective actions. In our national situation, I believe that a very public, *major decision point or break point* is required to Reform our broken 2-Party political system. So, I had to select an issue that was a well-known public grievance that had not been resolved for a long time. A national issue that other countries handled very well, but that our national leadership all but refused to deal with. Of course, we have many such problems, but I knew illegal Immigration had to be confronted and stopped for sake of the nation. Done!
6. Yes, the obvious national problem of uncontrolled, Illegal Immigration into our nation. I determined this after polling random people before the 2020 Presidential election. I heard Republicans say that if the Democrats got in, they would just open the borders and let anybody in. This was a major issue for them and DC would not stop it.

Most of the Democrats I spoke with were of course more pro-immigration. But I do believe the majority of them did not want the un-controlled borders either. Which told me very clearly that America was beyond ready to draw-the-line on immigration. Our politicians are politically gutless, they do not want to stop the illegal flow, and run from the “screamers” on social media.

7. Therefore, I determined to start building this politically Independent Reformation on confronting and resolving the Immigration problem. My 35+ year career was in Information Technology

working mainly in Washington, DC for corporations and federal agency clients. I am a business systems analyst and system designer.

I have researched and written about immigration and population management. After serious consideration and conversations with others, I concluded that a few major actions were required to bring Immigration under control. The simplest of solutions are often the best.

- All immigration via the US/Mexico border must be Suspended as of April 15, 2022, preferably! If Congress and the White House can't get it done by then, they must give us the date it will happen! And it better be before the Summer border rush.
- America is opting out of being a population dump site for the people of other nations.
- It will be easy to track because, **no** new immigrant Client Case Files would be created after April 15, 2022. Because we will no longer let anyone stay here that has attempted to enter without an official invitation from the proper US government agency and our Annual Quota System.
- We will also implement appropriate procedures to be enforced at all International airports. The regular entry point for at least 30% of Illegals entering the country.
- And we will implement the American National Identification Program (ANIP). We are one (1) of the few nations not to utilize such a standard administrative facility. It is why we have an IO problem. We cannot easily identify the IOs without a viable National ID System.

Now we will review the practical sequence of campaign events and related issues regarding the 2022 Election cycle and this Third-Party Movement.

8. Starting in March, I will begin Demanding that Congress and the White House implement the US Immigration Reformation Suspend immigration of ALL types at the US/Mexico border. And to do it by April 15, 2022.

Independent Volunteers Required for Success

9. TIPA will need your volunteer support nationwide and I need it now in Carroll County, Maryland. We are building the first TIPA Local Chapter right here. And it will serve as the TIPA National Chapter, as well. The public awareness of this Congress ultimatum is critical. Americans are going to be interested, if not totally delighted, if something like actually gets done. And it certainly could.
10. My campaign for the Maryland US Senate also kicks-off in March. Immigration is my campaign's lead Solution proposal. It is immediately followed by 40+ more proposals on TIPA Platform.

The Immigration Reformation proposal must catch on with the Public and spread across the nation in the weeks leading into mid-April. Thus, the people will learn about the various proposals and that there is actually an approach that could allow us to replace many politicians this very year. This will be the beginning of TIPA Local Chapters being set-up by Volunteers all over the country.

Long Story Short – It Does Not Matter What They Do

11. In the end, it does not matter what the Congress and White House does with this Demand. Either way we plan on starting the replacement of failed Republican and Democrat politicians. Of course, they will not want to close the borders. And if they delay, it will build a fire under this Independent Movement. And we win!

The TIPA Independent Party Movement will work to replace as many Incumbents as possible in 2022. We will be running candidates that will implement that Suspension. And getting me elected to the US Senate!

12. Again, we all know that for one excuse or a dozen, the US Congress Suspending immigration via the US/Mexico border is nothing they would ever want to do.

HOWEVER, they really will be caught between the proverbial rock-and-a-hard-place!! Because they will have the traditional pro-immigrant lobbyists whining on one (1) side and a fully aggravated and motivated majority of the American Electorate on the other. Should they recognize the public's disgust with Illegal Immigration, it could turn some votes. Time will tell...

Bluntly, if the Democratic Party wants to gain the respect of many voters and thus have a far better chance in this November's Election – the Dems will slam the US/Mexico border closed on 4-15-22... We will see if their Party leadership has the guts. Again, time will tell!

13. Needless to say, the whole public debate on the Suspension could drag-on for weeks and months. It would be great! The whole Independent Party Movement, the Platform, our growing Local Chapters, and potential TIPA Platform Candidates would be getting FREE publicity from the news media. Because the Press would like a real constructive 2022 campaign to report on for change.

TIPA Local Chapters and Candidate Qualifications (CQ)

14. I will not go into all the CQ twists and angles here. That detail is found to Strategy document mentioned above and located of the TIPA Platform website.

However, our go-to candidate type will be that of a Write-In. It actually gives us and our TIPA candidates more flexibility. In most States, Write-Ins do not even need to file until a few weeks before the November Election. We will know our candidates and be able file months earlier. Then campaigning could begin. Some candidates such as myself could go Write-In, but I could qualify as a Petition candidate.

15. While your first thought could be that a Write-In or Petition could be hard ways to run, but again when the Press starts reporting our Platform and Independent Movement – our candidates will be known. Once a potential candidate becomes known and liked by the Voters collecting signatures is not a problem.

We have started documenting the 2022 Election CQs for all 50 States. However, each Local Chapter will go to your State Board of Elections website to document the CQ for their potential

candidates elected office(s). It is not difficult to learn the data. The staff in those Election offices are helpful, but realize they get busier as the Election grows near.

The Ties that Bind this Independent Political Movement – The TIPA Platform

16. First, many people have told me that this project and campaign are a bit too radical and not likely to be victorious. They have said that while many of the proposals are really good there are some that are politically incorrect or socially sensitive. That we are fighting too many big lobbying groups and others not wanting the Masses to gain legislative control in the US Congress and 50 State Legislatures.

And that is exactly why one (1) of us needs to stand up and offer to lead. I am here volunteering and showing my commitment by running for the US Senate myself this year. I know I can do that job and be great at it. Because I am a patriot and a problem solver.

17. *The ties that bind*, and that must bind this upstart, Independent, Third-Party Movement together are:

- Love for our country and American Democracy.
- The Sense of Responsibility that we share with our fellow American citizens.
- The TIPA Independent Problem-solving Platform presented @ CommonSense2nd.com. It is not perfect, but it is a written legislative baseline
- ***The first rule of this TIPA Independent Movement*** and that every Local Chapter and every TIPA Platform Candidate must support the TIPA Platform as it written.

It was well researched, developed, and refined to serve the Common Good. Of course, as we get more into to the legislative process, legislation will be refined in keeping with resolving the problem in question.

- ***The second rule of this TIPA Independent Movement*** and that every Local Chapter and every TIPA Platform Candidate must support the TIPA Platform as it written.

If we stay true to the Independent Platform the Voters will gain more faith in the new Party and our candidates. We win!!

Thus, anyone that wants more Progressive/Liberal influence in their politics than we offer, can go to a **Democrats meeting!**

Also, anyone that wants a harder Conservative kick to their politics can go to a **Republican meeting.**

Finally, anyone that is a single-issue voter and does like part of our Platform, we will still work to build a better world for you to live in, too! Because we will not change the Platform. Ours is Moderate, problem-solving set of proposals aimed at the Common Good of our people.

18. TIPA Local Chapter meetings will inform the Public with Truth and the Facts. Over time the Local Chapters will help organize community projects.

19. As I developed those 40+ solution proposals over many years, my rule for each was to develop a proposal that some 65% of the Public could vote for if given the opportunity. Some people of course had to think about a given proposal for a while. Then, sometimes they would come back to me later and say that it would be better than anything else that has been tried or not!

I must point out that these solutions are not always what I would prefer to see done in a given situation. I would have been tougher in some cases.
