## ***We the People Demand a Viable Solution on Immigration***

We Americans are an overly patient people. However, we certainly do have an issue that grinds most Americans every time it is mentioned or jammed in our faces. That very solvable problem is the constant, uncontrolled migrant invasion of our nation. We the People, are rightfully disgusted with the US Congress for not protecting our borders. Both Parties have, are, and will continue to ignore this problem. No guts!

The domestic ***propaganda*** they feed us all the time is that We the People support immigration. However, the domestic ***reality*** is that **We only support legal, quota-driven immigration**. Got it!

I do offer that my professional career was 35-years in the Information Technology (IT) Industry. For several years in the 1990's, I worked as consultant to the US Immigration and Naturalization Service (INS). Myself and another guy wrote an upgrade to the IT system used to perform passenger check-in at airports and land border crossings. I inform you of that, so you know I have first-hand experience working with INS staff at HQ in Washington, DC and along the US/Mexico and Canadian borders, as well.

So, we ask, why does this invasion go on unchecked by the Congress. For the answer, let's quickly go back 36 years.

**In 1986**, then President Ronald Reagan passed the “one-time amnesty” and citizenship legislation that would up benefiting some three (3) million mostly Hispanics but also people from all over the world. Of course, it was only supposed to be about 1.5 million! Reagan also said at that signing, “Now we will get tough on employers so they quit hiring illegals.” We knew then, as we know now, that was a big joke on us.

Again folks, *please* understand that both Republicans and Democrats are equally at fault in failing to secure our national borders.

Why? Because, their large donors want a steady flow of cheap labor and/or more bodies legal or not to fill-up their rental units. So, do not allow the Republicans to claim any high-ground on immigration policy. Both Parties own the problem and ignore it.

**Now for the Truly Ugly Real Numbers – Brace Yourself**

**First**, the Federal government openly acknowledges that there are an estimated ten (10) million unknown IOs walking free within our borders. Evenly spread over those 36 years, it averages 277,777 IOs per year!! The same population as Plano, Texas; and Newark, NJ!!

**Second**, according to the group called, TRAC, the US Immigration Court has a current backlog of 1,755,934 cases. Of course, none of which are the IOs! Texas alone has 281,957 cases. And their Congressional delegation won’t touch the problem.

**A final perspective, is detailed in** the year 2000 and year 2020 US Census events. It documents our nation’s Citizen population racial growth.

- The White population went up less 1.5 million in 20 years. That is disturbing and will be discussed another time.
- The Hispanic citizen count increased an average of **1.2 million per year!**
- In the year 2000, the Hispanic citizen population was already 1,000,000 more than the Black. By 2020 that number grew 17,000,000. That my fellow Americans is what we can rightly declare as out-of-control border abuse.

In 36 years, neither Party in the US Congress or the White House administrations has done anything to STOP the “regular” migrant invasion, as these numbers clearly indicate. Also, the rarely mentioned dual invasion in the form of traveler Overstays – via our international airports!

## **The People's Simple Solution**

**“We, the Fully Aggravated American Public Demands that All non-Annual Quota Immigration is to be Suspended Immediately and Permanently”.**

Therefore, by the Power granted to us by the US Constitution – We the People, are granting the US Congress and the White House Administration, our collective permission to implement the TIPA Immigration Reformation Proposal overviewed below.

We the People believe in the KISS method of problem-solving. Which means, **“Keep It Simple Stupid”.**

Now of that is a joke, folks. It is hard policy, but the ONLY WAY to stop the unwanted migrant flow, but will also hammer the Hard Drug flow across borders substantially.

So, then I guess the nice people in Mexico can stop sending us Heroin, Fentanyl, and other killing agents. Fentanyl is a synthetic drug that is 80 times more potent than Morphine. It is responsible for 80% of overdoses in Maryland. Points made.

### Troops are Required at the US/Mexico Border

- To be very clear, in May and June and well into the summer months, there will still be hundreds of seats in the US House and Senate, and 50 State legislatures to be contested this November. In most States, Write-In candidates can still register up until just weeks before the November election! Of course, our candidates will File much earlier.

In fact, I will be running as either a Petition or Write-In type candidate myself. Not to be concerned if that initially sounds like an odd approach to you. It is a fully practical approach that they cannot block.

- Importantly, our potential TIPA Platform Candidates (TPC) will have a written and comprehensive Independent Platform of 40+ proposals that is acceptable to 65% or more of the Public. The 2-Parties cannot begin to touch that. Starting with TIPA Immigration Reform!
- We are starting a politically “Independent” Third-Party Movement. It just so happens that the political pollsters document that 40% of Voters have been leaning politically Independent for many years. Thus, Independents could now support a viable Independent Party and promote a practical, problem-solving Platform! What a concept!
- As the good news travels about the TIPA Platform and the real opportunity to remove useless politicians at all levels of government, I believe that folks across the country will respond.
